

Terms of Service

1. Acceptance of Terms

These Terms of Service (“Terms”) constitute a legally binding agreement between you (“User,” “Merchant,” or “you”) and CrossFund Protocol (“Company,” “we,” “us,” or “our”). Non-Custodial Service: You acknowledge that CrossFund Protocol is a non-custodial service provider. We do not have access to your private keys. You are solely responsible for the management and security of your wallet.
